23/75 Cheshire East

Cllr LS provided the following update:

CE has been awarded several grants, but none were applicable to this council.

The council expressed its disappointment in the services CE provide. The council feels it is effectively powerless in that there is no opportunity to access additional monies nor can change

decisions. The situation would only improve with adherence to a clear strategic plan and strong meaningful leadership.

23/77 Lower Church Hall Car Park

Fly tipping has occurred but clear up is complicated by the presence of asbestos which is now the responsibility of the landowner. This has meant the planned rewilding has had to be put on hold.

23/78 Millennium Green Trust

Cllr SB (via email)

New play area surface to be installed in 2023, moving away from the bark chippings approach. This will be a hard-wearing solution that won't need costly yearly maintenance. AGM was held on the Green in June, sadly with few visitors despite the advertising.

Bonfire being planned for Sat 4th November.

23/79 Village Housekeeping and Broadband

No call on the broadband expense and so will not be discussed at subsequent meetings. It was noted that some of the hedges especially on Pepper St were overgrown which was causing an issue especially when turning at junctions. Cllr DN volunteered to contact house owners, but nesting birds may not result in a swift resolution.

23/80 Environmental Project

Update Cllr SB (via email) that activity will be planned for winter.

23/81 Review of Trees

Cllr DN informed the council that there was only 1 tree outstanding to be cut back

23/82 Safety / Speed Limits

- Captured from discussions in 23/79 most of the road signage in and around Henbury is obscured by vegetation. Lack of maintenance by CE.
- Speed limit not being adhered to on A537. The Council initially requested a speed awareness device but were told that a camera was needed. However, upon inspection, a camera was not an option. No further communication has occurred.
- Since the repair of the culvert on A537 near the junction with Whirley lane the road

appears to be sinking on both sides

• All warning chevrons going into Birtles bends have been knocked down or are missing. Action: to ask highways officer for a report on the situation on Birtles bends (CIIr LS)

23/83 Footpaths and Flood Risk

Still no response from CE engineer on the Henbury to Whirley footpath. Council where aware of a planned meeting of CE with the Belway's engineer but not aware if it has occurred. Concerns were expressed that any testing of the drainage system would be extremely local ie to the confines of the building site. It was felt that this would not address the issue of flooding during sustained periods of rain and that not to involve the adjacent landowner was an oversight possible jeopardising a satisfactory outcome.

23/84 Highways

Broken cross junction: Cllr JB raised the issue of the lack of provision for visually impaired pedestrians. Cllr RS said he was meeting with David Rutley at the Broken Cross junction on Friday 14th July to discuss a number of safety concerns.
