## 3. A Formal Resolution to Close Down the Henbury Society

**Resolution** By away of debate and consultation this Committee has determined that the Henbury Society no longer plays a useful role in the community. Therefore, this Committee resolves to dispose of the society's assets to the benefit of the residents of Henbury before formally closing down the Henbury Society.

Proposed by Roger Cousin Seconded by Liz Welton Carried unanimously.

### 3. Disposal of the Society's Funds

The funds held by the Society are as follows: -

Current a/c: £ 699.44
Deposit a/c: £1578.55
Total £2277.99

The Committee has agreed that the funds held by the Society should be of benefit to the community of Henbury. It is proposed that a community event is to be held on the Millennium Green to celebrate the Queen's Platinum Jubilee in June 2022. It was agreed that the above sum should be donated to the body that will organise and run this event. However, if this event does not take place, then the money will be donated to the Henbury Millennium Green Trust towards the cost of running the Green for the benefit of the community.

# 4. Arrangements for Closing the Society' Bank Accounts

Roger will check the identity of authorized signatories Once it has been decided where the money will be donated to, Roger and Liz will make arrangements with the bank to close the account and transfer the funds to the relevant account.

Roger will consider what records are worthy of archiving, and investigate possibility of archiving at the Cheshire Archive, Chester or securely in the Church Hall.
